Although longer-term studies on mulch treatment effectiveness are on-going, early results and short-term studies have shown that dry mulches can be highly effective in reducing post-fire runoff and erosion. Hydromulches have been used after some fires, but they have been less effective than dry mulches in stabilizing burned hillslopes and generally decompose or degrade within a year.
