The LUSV program is a proposed new start project for FY2020. The Navy wants to procure two LUSVs per year in FY2020-FY2024. The Navy wants LUSVs to be low-cost, high-endurance, reconfigurable ships based on commercial ship designs, with ample capacity for carrying various modular payloads-particularly anti-surface warfare (ASuW) and strike payloads, meaning principally anti-ship and land-attack missiles.
