- Cut of the body made along a plane

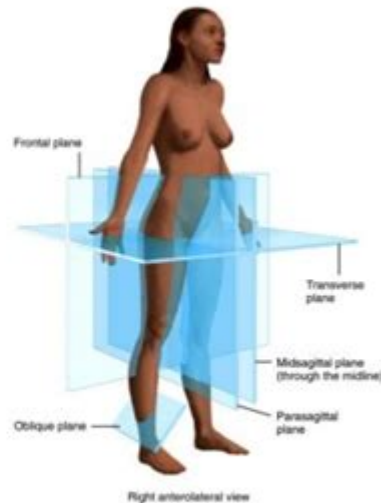


Figure 01.07: Tutorials - P&P 1.2w
